- **Augusta City Directories:** 41 reels; 1841-1960 with 1918, 1928, 1933, 1943 and 1944 missing.
- **Monsanto Company Administrative Records:** 2 reels; 1992 documents (letters, reports, scientific analyses, memorandum, ground water test results) detailing groundwater contamination caused by the Monsanto Augusta Plant during 1966-1974. Documents also detail the Monsanto Plant's placement on the National Priority List by EPA and ultimately being designated a Superfund site. Documents also detail the cleanup in 1983 of two landfills containing 1300 tons of arsenic trisulfide.

  - **Voice of Missions:** Reel 4; June 27, 1900, Atlanta, Georgia; published 1893-1900 by Missionary Department of the African Methodist Episcopal Church.
  - **Augusta Union:** Reel 4; 1900, Augusta, Georgia; published 1889-1904.
  - **Columbus Chronicle:** Reel 4; June 27, 1900, Columbus, Georgia; published weekly 1895-1900.
  - **Macon Sentinel:** Reel 4; January 27, 1900, Macon, Georgia; published 1899-1900.
  - **Gazette & Land Bulletin:** Reel 4; January 27, 1900, Waycross, Georgia; Brunswick, Georgia.

  - **Augusta Courier:** 5 reels; April 1946-1974; segregationist newspaper founded by Roy V. Harris.
  - **Augusta Evening Dispatch:** 2 reels. Reel 1: January 20, 1858-December 1858; reel 2: January 1859-June 6, 1861. Published by S.A. Atkinson. Other titles: **Evening Dispatch**.
  - **Richmond County Times:** 5 reels. Reel 1: February 16, 1956-June 1967; reel 2: July 1967-July 1973; reel 3: August 1973-June 1981; reel 4: July 1981-September 1985; reel 5: October 1985-December 1987. Fleming Publishing Company, formerly the Fleming News. Politically neutral, focused on agriculture and industry. Originally only covered the Fleming community, but later all of Richmond County. Began May 6, 1954.
  - **The Daily Register:** 1864-1865; reel 1: September 16, 1864-December 6, 1864. Published by Brown, Whitner & Company.
  - **Trench and Camp:** 1 reel; October 10, 1917- January 29, 1919. Published under the auspices of the National War Work Council of the YMCA of the United States and under the cooperation of the *Augusta Herald*. From 1914-1918 called the **Camp Hancock Trench & Camp**.
  - **The News Review:** 5 reels. Reel 1: March 25, 1971-December 30, 1971, then became **The Augusta News Review**. Reel 2: November 22, 1972-December 30, 1976. Reel 3: January 1977-

March 1980. Reel 4: April 1980-June 1983. Reel 5: June 2, 1983-March 16, 1985. African-American newspaper, published by Mallory Millender.

- **Constitutionalist**, 1 reel; January 4, 1825-December 1827. Began July 1, 1823, ceased June 1832. Published by W.J. Bunce. Succeeding title: *The Georgia Constitutionalist*.
- **The Georgia Constitutionalist**, 9 reels. Published by Guieu and Bunce, 1832-1844. Succeeding title: the *Daily Constitutionalist*. Reel 1: June 1828-February 1833; Reel 2: March 1833-August 1834; Reel 3: September 1834-November 1832; Reel 4: December 1835-1837; Reel 5: April 1837-June 1838; Reel 6: June 1839-July 1839; Reel 7: August 1839-October 1840; Reel 8: November 1840-December 1841; Reel 9: January 1842-December 1844.
- **Daily Constitutionalist**, 58 reels. October 1846-March 1877, Missing: July-December 1851; January-June 1852; January-June 1854; July-December 1855.
- **Augusta Weekly Constitutionalist**, December 31, 1856-December 21, 1859.
- **Mirror of the Times**, 1 reel; published by Daniel Starnes & Company, 1808-1814. October 24, 1808-March 19, 1814. Succeeding title, *Georgia Gazette & General Advisor*.
- **Georgia Courier**, 1 reel; published by Brantley & Clarke. June 7, 1827-December 25, 1828; October 7, 1830.
- **Tri-Weekly Chronicle & Sentinel**, 2 reels; January 1838-September 1839; October 1839-1841. Published by, J.W. and W.S. Jones from 1838 to 1877. Preceding title, *Chronicle & Sentinel*; succeeding title, *Tri-Weekly Constitutionalist*.
- **Chronicle & Constitutionalist**, 2 reels; January 1838-September 1839; October 1839-1841.
- **Miscellaneous Augusta, Georgia Historic Newspapers**, 3 reels.
  - Reel 1: **Augusta Weekly Chronicle**, August 29, 1835-December 31, 1836; **Augusta Daily Constitutionalist**, October 1, 1835-April 1, 1836; **Augusta State Rights' Sentinel**, January 9, 1834-January 5, 1835, published by A.B. Longstreet; merged with the *Augusta Chronicle*.
  - Reel 2: **Augusta State Rights' Sentinel**, June 2, 1835-December 28, 1836; **Augusta Chronicle & Georgia Gazette**, January 31, 1822-August 5, 1822. Published by Kean, Duyckinck & Pearre. Became the *Augusta Chronicle*. **Augusta Chronicle & Georgia Advertiser**, September 28, 1822-September 21, 1825. Published by T.S. Hannon from 1822 to 1831; succeeding newspaper the *Augusta Chronicle*.
